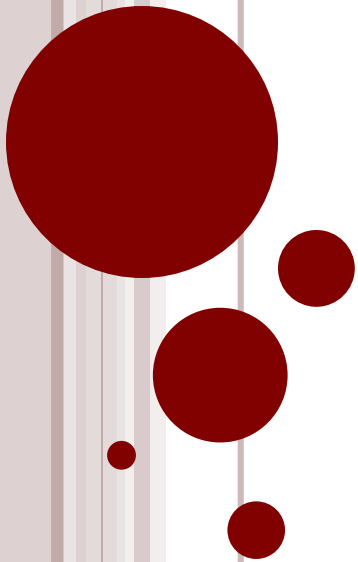

# SECURITY POLICY CHANGE

## ➤ From budgetary cuts affecting the entire police and judicial system

- The federal police and justice system has been subjected to the same cost-cutting measures (-20%, -12%)
- From 1,200 to 1,400 hires per year to 600 per year
- 20% personnel shortage for the federal police

## ➤ Towards selective reinforcement

- Immediate measures (soldiers in the streets; concentration of police force on targets and regions under threat)
- Increasing recruitment; strengthening units involved in the fight against terrorism

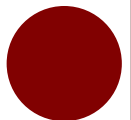

# **BROADENING THE JURISDICTION OF POLICE, SECURITY SERVICES AND PUBLIC MINISTRY**

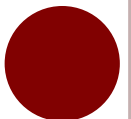
- **Close monitoring of FTFs and ‘radicalised’ individuals**
- **Strengthening administrative measures**
- **No state of emergency**
- **Balance between:**
  - Efficiency of repressive measures
  - Rule of law and democratic freedom guarantees



# **BROADENING THE JURISDICTION OF POLICE, SECURITY SERVICES AND PUBLIC MINISTRY**

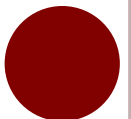
## **THE CHALLENGE**

- **ENSURING THAT THE POPULATION IS PROTECTED**
- **WITHOUT ALLOWING TO ERODE OUR VALUES, DEMOCRATIC FREEDOMS AND THE RULE OF LAW**



# **ACTION PLANS AGAINST RADICALISATION AND VIOLENT EXTREMISM**

- **Exchange of information and registration**
- **Monitoring of FTFs (candidates):**
  - Close and permanent monitoring: LTF (Local Task Force)
  - ID papers
  - Underlying phenomena: weapons, drug and document trade, illegal trade
- **Follow-up per municipality: CLSI (local cell for integral security)**
- **Policy on education, youth, etc.**
- **How to deal with mosques and Muslim communities**



# **ACTION PLANS AGAINST RADICALISATION AND VIOLENT EXTREMISM**

- **WINNING THE STRUGGLE OF IDEAS**
- **ENSURING SOCIAL COHESION**



## **EMERGENCY PLANS**

- **State Territorial Representatives have been tasked with specific plans in the event of a terrorist attack**
- **Clarification of roles and responsibilities of the prosecutor and administrative authorities**
- **Coordination at the national level and management committee at the provincial level**
- **Aid and specific acknowledgement granted to victims of terrorist acts**
