Mr. Ignazio PORTELLI, Prefect, ANFACI's President and President of the EASTR (Italy)



Prefect, he was head of the legislative office of the Minister for International Cooperation and Integration.

Over the years he has been involved in: reform of state apparatus; local government; electoral systems; mafia crime; organization and functioning of police forces; procurement; airports; budget of the Ministry of the Interior. As prefectural commissioner, he has administered many municipalities, including the city of Rome. Later, he was an Inspector General of Administration of the Ministry of Interior and carries out special assignments.

Currently, he is the prefect of Frosinone, a city near Rome.

In addition, he is Anfaci's President, and before he was Secretary General and, for nine years, Deputy Secretary General.

He is among the founders of our European association (AERTE/AESTR) and he was its first Secretary.

Opening session

Mrs. Laura LEGA, Prefect, Head of the Department of Firefighters, Public Relief and Civil Defense at the Ministry of the Interior (Italy)



Born in Rome, she graduated with honors from La Sapienza Law School (University of Rome) (1983). She worked at a bank institution in Milan and, later, for a financial company.

She started her prefectural career in 1989. After a short period at the Prefecture of Rome, she was then assigned to the Research Office for the General Administration and Personnel Affairs where she has been dealing with regulatory and consultative activities.

From 2001 to 2006, in an untenured position, she held the role of Deputy Head of Cabinet of the Minister of Labor and Social Policies.

In 2006 she returned to the Ministry of the Interior and, after managing the Coordination Office of State Administrations, until 2008 she was the Director of the General and Legal Affairs Office at the Office for the Coordination and Planning of the Police Forces, within the Public Security Department.

From 2007 to 2010 she also held the position of Chief of the general coordination and implementation of the Memorandum of Understanding between the Ministry of the Interior and the Friuli Venezia Giulia region on integrated urban security policies.

In 2008 she was appointed Director of the Office for Research and Analysis, Legislative and Parliamentary Affairs and, in 2009, she was appointed Chief of the Cabinet Office of the Head of the Personnel Policies Department of the Civil Administration of the Interior.

In December 2010 she was appointed prefect by the Council of Ministers.

From August 2011 to August 2015 she held the position of Deputy Head of Department - Central Director of Human Resources at the Department of the policies for Civil Administration personnel and of Equipment and Financial Resources.

From August 2015 to July 2018 she was the prefect of the province of Treviso.

From July 2018 to November 2020 she was the prefect of Florence.

From 30 November 2020 she is the Head of the National Fire Service, Public Rescue and Civil Defence Department.

She is an effective member of the Higher Council of Public Works.

During her career she has been a member of competition and tender committees as well as of numerous working groups such as those relating to the organization of the central and local offices of the Ministry of the Interior, the reorganization of the prefectorial career and the identification of posts pursuant to legislative decree N. 139/2000. From 1999 to 2001 she was the general representative of the "CAMBIA P.A." project, promoted by the Presidency of the Council for the "Development of knowledge about innovation and review of the innovation processes ongoing in central public administrations". In May 2020, she represented the Administration at the "First Conference on Public Administrations quality" which took place in Lisbon (Portugal).

In 2001 she was appointed Sub-Commissioner for Salerno municipality. From April 2010 to May 2011 she held the position of Sub-Commissioner for Latina municipality.

She has been a lecturer at various Italian universities and is the author of scientific publications.

She is married with two sons.

Mr. Dario NARDELLA, Mayor of Florence (Italy)



Dario Nardella was born in Torre del Greco (Naples) on November 20th 1975. He is married to Chiara and father of 3 children. He graduated in Law with first class-honours at the University of Florence, where he got a Ph.D. in Public Law, Construction and Environmental Law. He is also a graduate in violin from the "Conservatorium Cherubini" in Florence. Professor at the University of Florence where he teaches Cultural Heritage Law, he started his political career in 2004 when he was elected Councilman for the City of Florence in the Democratic Party.

He served as legal advisor to the Minister of Institutional Reforms during Romano Prodi's premiership (2006-2008). In 2008 he was selected by the U.S. State Department as young Italian politician to attend the International Visitor Leadership Program. In 2009 he was once again elected to the Florence City Council and appointed Vice Mayor in the City Government of former Mayor Mr. Matteo Renzi.

In February 2013 he was elected to the Chamber of Deputies of the Italian Parliament and Member of the Commission for tourism, industry and trade.

In February 2014 Dario Nardella was appointed to the regency of the City until next elections, after Matteo Renzi's resignation and subsequent appointment as Prime Minister.

After winning primaries for the Democratic Party, in May 2014 Nardella has been elected Mayor of Florence with 59,16% on first ballot. He also serves as Mayor of the Florence Metropolitan City, which includes 44 towns of the metropolitan area. In June 2014 Dario Nardella has been elected as ANCI (National Association of Italian Municipalities) coordinator for metropolitan cities. He has been member of the Global Executive Committee of ICLEI - as Representative for the Europe Regional Seat and Vice President of Eurocities. In May 2019, he has been re-elected on the first ballot, with the 57,5% and he's currently serving for the second tenure. He's also been serving as President of Eurocities since November 2020.

Mr. Eike SCHMIDT, President of the Uffizi Gallery (Italy)

"Protection and valorization of museums and churches"



Eike Schmidt embarked on his long career, first as a museum curator and then as a director, in 2001 with the National Gallery of Art in Washington, subsequently moving to the J. Paul Getty Museum in Los Angeles, before taking up the post of Director of the Department of Sculpture, the Applied Arts and Textiles at the Minneapolis Institute of Arts in Minnesota with its collection of over 20,000 items, a number that grew considerably under Schmidt thanks to his sensational purchases on the art market. Indeed the works he bought for the museum were named "acquisition of the year" by the prestigious art magazine Apollo, one of the leading periodicals in the field on fully eight separate occasions, and he was to achieve the same award again for two paintings, Daniele da Volterra's Elijah in the Desert and Giuseppe Bezzuoli's Eve Tempted by the Serpent, and for a rare group of drawings by Massimiliano Soldani Benzi, which he purchased for the Uffizi in 2018.

Thanks to his connoisseur's flair, he was appointed Director of the Department of European Sculpture in the celebrated London-based auction house Sotheby's in 2008 and 2009. An international authority on sculpture, he was also a member of the jury for the TEFAF art and antiques fair in Maastricht, the most important such fair in the world for antique dealers and collectors, for six years (until 2015).

In parallel, he has never ceased to devote his unflagging energy to scholarly research, with approximately 200 books and articles currently to his name, in addition to curating a number of exhibitions. In Italy, he co-curated the absolutely pioneering exhibition entitled Diaphanous Passions: Baroque ivories from the courts of Europe in the Pitti Palace in Florence in 2013, which not only chalked up a record number of visitors but also marked a turning point in its field of study.

In November 2015 Eike Schmidt was appointed Director of the Gallerie degli Uffizi, a museum cluster comprising, in addition to the Uffizi Gallery proper, another 11 museums hosted in the Vasari complex, the Pitti Palace and the Boboli Garden. The awards he has received include the Excellency Award from the Foundation for Italian Art and Culture in New York in 2017, while that same year he was appointed Honorary Professor of Art History at the Humboldt Universität in Berlin. In 2018, Blouin Artinfo, a leading global site specialising in the arts, added Schmidt's name to its list of 10 best museum directors in the world thanks to the outstanding results he has achieved since taking over at the helm of the Uffizi. Also in 2018, using the tools of cultural diplomacy, he succeeded in bringing back to the Pitti Palace a painting depicting a Vase of Flowers by 18th century painter Jan van Huysum which had been stolen by the Nazis in 1944. He has been Chairman of the Board of the Fondo Edifici di Culto since 2019. He is the author of numerous publications.

Professor Cathy Berx studied Law at the University of Antwerp, where she received her Master of Laws degree summa cum laude in 1993. As a researcher at the Fund for Scientific Research Flanders, she obtained in 1998 her Ph.D. in public law entitled: 'Legal protection from the citizens against the government'. In this specific domain, she published several prize-winning books. She has been working as a professor at the University of Antwerp from 2000 onwards, teaching the following courses: 'Law of the decentralized governances' (2nd Ma) and 'Juridical skills Debating Class' (1st Ba).

From 2001 until 2007 she was vice-chairman of the Social Service Department in the city of Antwerp. In the period between 2003 until 2008, she was vice-chairman of the Christian Democratic Party. She joined the Flemish Parliament in 2004 until April 2008. Cathy Berx was a top staff member of former Minister-President and Prime Minister Yves Leterme. In that function, she was closely involved with the formation of the Flemish government (2004-2009), as well as with the negotiations in order to form a new federal government at the end of 2007 (Leterme I). From 2007 until 2008 she was a member of the Antwerp City Council.

Regularly, she represents the Antwerp province at home and abroad.

Born in Campania, sixty-five years old, graduated in Law at the university "Federico II" of Naples, entered the Administration of the Interior in December 1982, designated to the Prefecture of Florence. Since then, successively, he is assigned to the Ministry in Rome, then Caserta and after that he conducts his role of head of cabinet in Massa-Carrara, Florence and Milan, where he finally carries out vicarious functions. Appointed as prefect in 2009, he became the responsible of the offices of Monza and Brianza, Siena, Turin until October 2018, when he assumed the current position of prefect of Milan.

A professional formation almost entirely built in the territory, in the Prefectures, in harmony with an inclination to face real processes by promoting and tightening collaboration networks with the several forms of the local reality.



Among the most important activities, the contribution to the excellent outcome of the European Social Forum in Florence in 2002, just one year after the G8 in Genoa; the "establishment" of the new prefecture of Monza and Brianza; the reconnection with the world of the districts in Siena in the middle of the Monte dei Paschi crisis; the real start of the "soft eviction" of the former Olympic village of Turin seized by almost a thousand non-EU citizens; the dismantling of the "drug grove" in Rogoredo park in Milan, one of the largest "open-air markets" of drugs, with the full enhancement of the vast urban park, the adhesion of dozens of drug addicts to rehabilitation centres programmes, the arrest of entire drug dealing organizations.

Since 1991, from the Albanians of thirty years ago to the Afghans who have now arrived with the humanitarian corridors, in the different offices and duties, he has always managed the challenging events of mass arrivals and reception of refugees from all over the world.

In Turin, he devised and signed agreements with 134 municipalities which have taken over the direct management of the widespread hospitality of asylum seekers, resulting in a balanced territorial distribution, a greater chance of inclusion and social control.

In addiction, in his Turin years, he established productive relationships with colleagues from beyond the Alps, culminating in the signing with the Prefect of the Auvergne Rhône Alpes Region - in Modane on February 22, 2018 - of the first binational agreement for anti-mafia investigations on Italian and French tenders of the cross-border section of the new Turin - Lyon railway line.
